TERMS AND CONDITIONS

7. Payment of books shall be made after proper verification of each title and author by the concerned HOD/Teacher/ Library.

8. Security deposit in the form CDR amounting to Rs 5,000/only should be pledged to the Principal Government Degree Kalakote . Security deposit in the shape of Cheque/Cash shall not be accepted.

9. The supply is to be made within 15 days from the date of issuance of supply order failing which firm may be penalized by the College.

10. Conversion rate for the foreign currencies as recommended/approved by Goods Office Committee, New Delhi shall be enforced.
